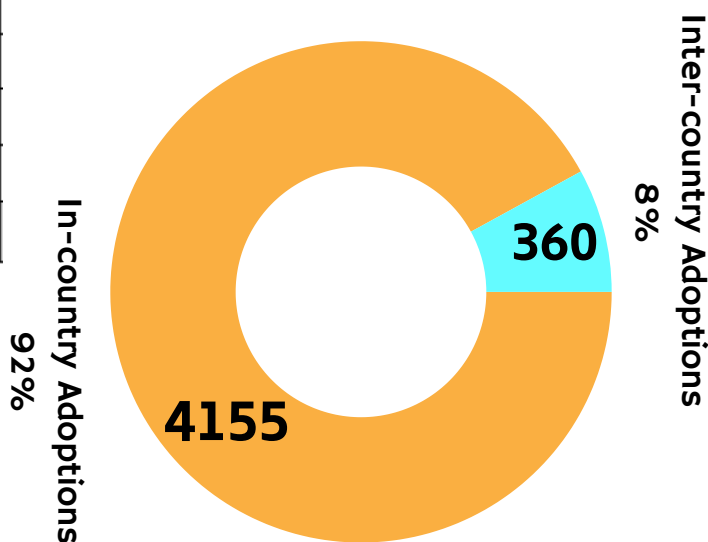

# *Updates* POLICY AND CARINGS



**During FY 2024-25**, several policy decisions have been taken by CARA to steadfast the adoption programme. Many enhancements were made to the CARINGS portal as a result to some decisions as well.



- As per the directions of Hon'ble Supreme Court, children are now identified in 5 categories - Orphan, Abandoned, Surrendered, No Visitation and Unfit Guardian(s).
- With the identification drive of children, addition of new stakeholders was also achieved. 200+ new SAAs are established & total SAAs are at 708.
- Timelines for In-country Relative and Step Parent Adoption have been developed to streamline the adoption ecosystem in the country.
- Online module for Foster Care has been developed and made operationalized on CARINGS portal.
- Adoption fees, once disbursed by PAPs, will not be applicable for return/ reimbursement.

**11 & 12 March 2025** | Representing India in the 'Asia level workshop on implementation of Hague Convention, 1993', the officials of CARA presented the key aspects of Juvenile Justice Act, 2015 (as amended in 2021) and Adoption Regulations, 2022 in the context of Inter-country adoptions.



In the presence of dignitaries from 9 other countries, CEO CARA held the stage to represent India's implementation of the Adoption Convention, 1993. She also presented the process of Matching, Child Preparation and Socialization in India, while taking active part in the discussion of case studies being brainstormed in the forum.

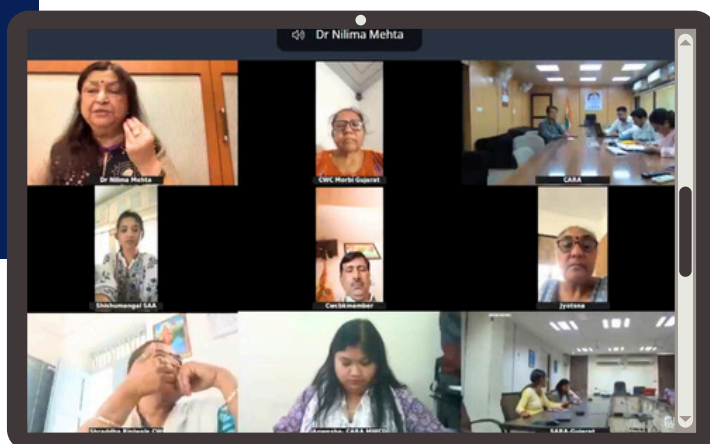

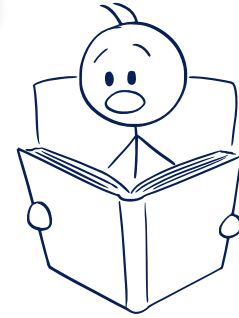

# SUCCESS STORIES OF ADOPTION



## राधा को मिला एक घर: आशा और प्रेम की कहानी

अगस्त 2023 की बात है जब 20 दिन की राधा (परिवर्तित नाम), जो जन्मजात विकृति 'फोकोमेलिया' के साथ पैदा हुई थी, होप हाउस के विशिष्ट दत्तक-ग्रहण अभिकरण में आई। उसके पैर भले ही इस स्थिति से प्रभावित थे, लेकिन वह बेहतर होने के लिए पूरी तरह समर्पित थी।

CARINGS पोर्टल पर सूचीबद्ध होने के बाद, राधा को 18 अंतरराष्ट्रीय दत्तक परिवारों ने अस्वीकार कर दिया था। जब उम्मीद टूटने लगी, तब एक भारतीय दंपती आगे आया। उन्होंने उसकी चिकित्सीय स्थिति को समझा, समय विस्तार का अनुरोध किया, और अंततः दिसंबर में गोद लेने का निर्णय लिया।

26 दिसंबर 2024 को राधा को फॉस्टर केयर के तहत उनके प्यार भरे घर में सौंप दिया गया है। फरवरी में, गोद लेने की प्रक्रिया कानूनी रूप से पूरी हुई। आज, वह अपने माता-पिता के साथ खुशी से आगे बढ़ रही है, जो उसे हर चुनौती से पार पाने के लिए प्रोत्साहित कर रहे हैं। यह प्रेरणादायक कहानी दर्शाती है कि विशेष जरूरतों वाले बच्चों को अपनाना कितना महत्वपूर्ण है।

Through this structured care and guidance, Dhriti received an incredible opportunity—adoption by a loving family in New Zealand. The adoption process was carefully managed to ensure a smooth transition into her new home, where she was welcomed with love and care.

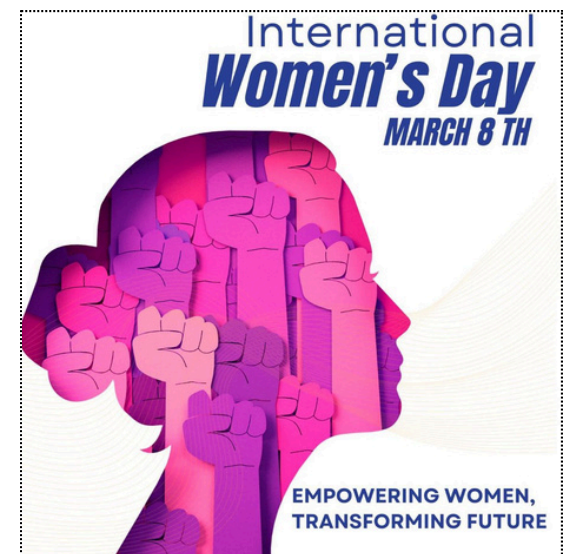
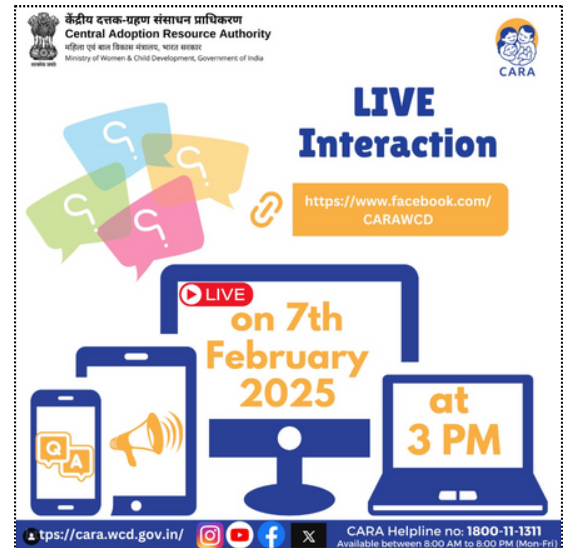


