OFFICE MEMORANDUM

Subject: Uploading of Adoption Orders in cases of In-country Relative/Step child adoptions

Regulation 54(9) & 55(8) of the Adoption Regulations 2022 mandate that, "The District Child Protection Unit shall obtain a certified copy of the adoption order from the District Magistrate concerned and furnish a copy of the same online to the Authority and the adoptive parents through the Designated Portal".

2. This has been observed that in cases of Relative/Step adoption, the concerned DCPUs are not uploading the adoption orders, and the pendency is shown at the level of Court/DM. State wise pendency for the past 3 years is placed at **Annexure I**.

3. All SARAs are kindly requested to take up the matter on priority basis with their respective DCPUs asking them to upload the finalised adoption orders by 17th March 2023 on the CARING's Portal.
