Minutes for the 11th Meeting of the Steering Committee of Central Adoption Resource Authority (CARA) held on 10th November, 2017 at 03:00 p.m. in the Conference Hall of CARA at West Block - 8, Wing - 4, 1st Floor, R K Puram, New Delhi.

- 1. The 11th Meeting of the Steering Committee of Central Adoption Resource Authority, chaired by Shri Rakesh Srivastava, Secretary, MWCD (Chairperson of Steering Committee of CARA), was held on 10th November, 2017 at 3:00 p.m. in the Conference Hall of CARA at West Block VIII, Wing IV, 1st Floor, R.K. Puram, New Delhi.

- 3. At the outset, Chairperson, Steering Committee welcomed all the Members of the Committee and asked Member Secretary & CEO, CARA to present the Action Taken Report of the last Meeting held on 1st September, 2017 and the Agenda Items of the current Meeting.
- 4. Member Secretary & CEO, CARA welcomed the Chairperson and all the Members attending the 11th Meeting of Steering Committee of CARA. He informed that as the anniversary of CARA is on 15th January 2018, there would be one more Meeting before the two years tenure of the members (other than ex-officio members) gets completed. Before beginning the discussion on Action Taken Report of the Meeting held on 01.09.2017, CEO CARA shared the relevant statistics on Adoption (copy of the presentation is at Annexure-II). He informed that there were total of 5211 children in Homes out of which 1865 children were in foster care and 1925 children were available for adoption. There were 1007 children which were Special Needs Children who were legally free for adoption. Further, 18052 parents were registered for In-country adoption and 874 parents were registered for Inter-country adoption. He also informed that 1765 adoptions had been concluded by RIs and NRIs from April 2017 till 09.11.2017 and 379 adoptions by OCIs & Foreigners. With regard to Court pendency, he informed that a total of 756 cases were pending beyond the stipulated timeframe of two months in various courts in India. The maximum pendency was in Tamil Nadu (139 cases), Telangana (128 cases), West Bengal (115 cases), Odisha (91 cases), Maharashtra (77 cases) and Bihar (59 cases).
- 5. Further, CEO CARA informed that as on 09 Nov 2017, 282 CCIs were linked with SAAs wherein 121 children were below 6 years and 1594 children were above 6 years. He informed that out of the children in SAAs/CCIs as on 09.11.2017, 1925 children were legally free, 722 children were CNCP and 2440 children were yet to be declared legally free. He also informed that 395 new children have been registered in CARINGS during this month. Out of 274 children placed in adoption during this month, 180 children belonged to In-country (taken in pre-adoption foster care) and 94 children belonged to Inter-country (NOC issued).

Agenda Items and Decisions (Administration, Accounts & Financial Matters)

Item No. 1: Reviewing the Role & Charter of CARA and the Requirements of Strengthening by Restructuring & Revamping of the CARINGS Module

- 7. We may engage a professional consultancy service to look into the exact role & charter of CARA and suggest the methodology of functioning as well as the resources required. Based on the suggestions backed by assessment duly reasoned through a Detailed Project Report, MoF, GoI may be obliged to favourably dispose off the Restructuring Proposal.
- 8. Further, CARINGS, an application for smoothening of adoption process in the CARA website need to be reviewed as it has become nonfunctional at certain points. It was made almost a decade ago just for recording the offline adoption data. With patch work, it is now being used for running the important live application which requires lot of features and functionalities. However, the report generation mechanism is out dated and isn't user friendly. Lots of complaints are received by all Stake Holders including the SARAs, SAAs, AFAAs and the PAPs, as could be seen in the meeting dated 24 Oct 2017. We need to upgrade it and have a search based report generation as well as dashboard which force the SAAs & SARA to update the details. NIC is finding it difficult to manage it, and here also we may explore utilising the services of CDAC, which is also an organisation under MEITY.

Decision:

- 9. It was decided that the requirement of the Restructuring Proposal already under consideration of MoF be pursued as it has been recommended by the Ministry.
- 10. As regards CARINGS, the requirement of its upgradation was accepted by the Steering Committee. However, it was suggested that services of NIC, being a Government Department, be taken for the revamping project. It was also advised that the requirement of formulating a detailed proposal for Revamping the CARINGS be given to NIC formally through a letter.
- Item No. 2: Approval of Additional Miscellaneous Expenditure during the Two days Orientation-cum-Sensitization Programme on Adoption under the Juvenile Justice Act for the Directors of State Judicial

- 11. An amount of Rs.6,47,620/- was sanctioned in favour of the Director, National Judicial Academy, Bhopal for organizing the Two days Orientation-cum-Sensitization Programme on Adoption under the Juvenile Justice Act for the Directors of State Judicial Academies & other Judges at National Judicial Academy (NJA), Bhopal on 8th & 9th April 2017 by CARA in collaboration with NJA, Bhopal.
- However, the Expenditure Statement received from the Registrar 12. (Admn.), NJA (vide his Letter No. NJA/Accounts/SE/CARA/2017/1881 dated 02 May 2017), excess expenditure of Rs.1,52,846/-was incurred by the Academy under the Administrative Expenses head primarily due to hiring of taxis for local conveyance of the participating Judges as the Resource Persons as well as the Participants of the aforesaid Programme. Administrative Expenses amounted to Rs.1,52,846/-(according to the Expenditure Statement received from the Academy) primarily due to hiring of taxis for local conveyance of the participating Judges (annexed). However, the amount sanctioned under the administrative expenses head for the Programme was only Rs 50,000/- per Programme (as per the sanction order issued which is based on the approved norms). Further this Programme was spread over a period of two days instead of generally the same being organized on one day. Hence the Balance amount of Rs.1,02,846/- may be approved for payment to NJA against the expenditure incurred during the Orientation Programme held on 8th & 9th April 2017 at National Judicial Academy, Bhopal.

Decision:

13. In Principal it was approved, however it was decided that the same be moved on file to the Ministry with justification for the extra amount spent, on hiring of taxis for participating Judges in the said Orientation Programme, by the NJA.

Item No. 3: Information of Fourth Meeting of the Advisory Committee of CARA was held on 21/09/2017.

14. Fourth Meeting of the Advisory Committee was held on 21st September, 2017 chaired by Sh. Rakesh Srivastava, Secretary, MWCD. In order to provide an overview of the present adoption programme and to orient the Members to the existing challenges and way forward, CEO, CARA made a Presentation to members of the Advisory Committee, which include

15. CEO CARA informed that it was included in the minutes of its Meeting regarding a letter issued by the Ministry on TA/DA with due concurrence of MoF. It was mentioned that we will be paying Economy class Airfare to Advisory Committee Members since they are non-Government officials. Further, we will be paying DA as applicable to Dy. Secretary level in the Government.

Decision:

16. It was advised by Steering Committee to follow the rules/circulars issued by the Govt. on the entitlement applicable to Non-Govt. Officials.

Item No. 4: Information related to TA-DA for Social Workers working with Govt. run SAAs.

17. The stipulated Adoption expense for Home Study Report (HSR) of PAPs in India by Social Worker is Rs.6000/- inclusive of travel expenses payable to SAA or authorized social worker through demand draft or bank transfer. The Post-adoption follow up visits and counselling (4 times within a period of two years) is Rs.2000/- per visit or report. However, it has been observed that there are several Govt. run SAAs which are not paying TA-DA to their social workers for doing the HSR & post adoption follow-ups, though the PAPs/Adoptive parents are charged fees for the same. The Steering Committee may like to take an appropriate action in bringing out a strategy so as to pay requisite honorarium to the social workers working under SAA 21who conduct HSR etc.

Decision:

18. It was informed by Steering Committee that rules are there for paying TA/DA to officials. DA can be given as per Govt. norms to the Social Workers if they go beyond the city limits for conducting HSR. It was directed to issue a circular to the SARAs & SAAs in this regard.

Item No. 5: Issuance of the Instructions to all SAAs regarding Utilisation of adoption Fees.

- 19. Adoption fees earlier known as Child Care Corpus (CCC) meant for adoption agencies for incurring expenses for the welfare of children while they are in institution. The Adoption fees collected must specifically be utilised for the services rendered during the adoption process and for the welfare of the children. It is proposed that clear cut instruction on utilisation pattern for adoption fee may be decided as under:
 - (a) All cost for conduct of medical tests and treatment of the children including getting the MER prepared as prescribed in the standardised Government hospital rates fixed by respective state health authorities.
 - (b) SAAs may spend the money in getting the medical insurance cover for the children till they are placed in adoption.
 - (c) The expenditure on strengthening cognitive development in children and counselling of older children for preparing them for adoption
 - (d) Legal expenditure with suggested capping given in earlier Circular. Copy of the same was placed at **Annexure-E** of the Agenda.
 - (e) Valid expenditure in obtaining birth certificates and passport of the children.
 - (f) Miscellaneous expenditure during the adoption process like conveyance/transportation of staff for attending/Visiting CWC & court hearings, DCPU, Police, CCI etc. may be borne. However, it should limited to 10% of the total adoption fees collected.
 - (g) Incentives for Staff of SAAs for their services and other expenses not provided in the ICPS budget which is strictly meant for the welfare of children.
- 20. The Steering Committee may approve the same.

Decision:

21. It was advised by Steering Committee that the adoption fees collected by the SAAs, should not be used for making building etc. It was advised that this be examined on file by the Ministry, being a policy matter.

Item No. 6: Approval of the Steering Committee for draft Annual Report of CARA for the year 2016-2017 and their printing.

- 22. As per Section 71(1) of the Juvenile Justice (Care and Protection of Children) Act 2015, the Authority shall submit an Annual Report to the Central Government in such manner as may be prescribed and the Central Government shall cause the Annual Report of Authority to be laid before each House of Parliament Authority [Section 71(2) of J.J. Act, 2015 refer]. Further, as per Section 69(3)(b) of the J.J. Act 2015, the Steering Committee of CARA shall have to approve the Annual Budget, Annual Accounts, and Audit Reports as well as the Action Plan and Annual Report of Authority. Moreover, the Annual Accounts for the year 2016-2017 has been approved by the Steering Committee in its 8th Meeting held on 29/06/2017. The DGA(CE), New Delhi has also audited the aforesaid Accounts of CARA and Audited Report is awaited. The same will be incorporated in the aforesaid Annual Report after receiving from the DGA(CE), New Delhi.
- 23. As per the Para 22 of the Financial Power of the Service Bye-laws of CARA, Member Secretary & CEO(CARA) has full powers subject to Item No. 14 of Schedule-V of DFPR & relevant rules/ orders issued by GOI on the subject [Head of Department (HOD) upto Rs.20,000/- per annum] and Management Committee, CARA (now Steering Committee of CARA) has full powers to printing, binding and publication of journals & periodicals.
- 24. The Steering Committee may please approve the draft (English version) Annual Report of CARA for the year 2016-2017 and its printing, as per the provisions of General Financial Rules (GFRs).

Decision:

25. The Annual Report for the year 2016-17 was approved. The expenditure to be incurred on the printing was also approved.

Item No. 7: Information of digital printing of Annual Report of CARA for the year 2015-2016 (Agenda Item No. 1 of 10^{th} Meeting of the Steering Committee related)

- 26. The Steering Committee of CARA has approved the draft Annual Report of CARA for the year 2015-2016 in its 9th meeting held on 27/07/2017.
- 27. As per the para-22 of the Financial Power of the Service Bye-laws of CARA, Member Secretary & CEO(CARA) has powers subject to Item No. 14

- of Schedule-V of DFPR & relevant rules/ orders issued by GOI on the subject [Head of Department (HOD) upto Rs.20,000/- per annum] and Management Committee, CARA (now Steering Committee of CARA) has full powers to printing, binding and publication of journals & periodicals.
- 28. As per the GFR provisions, a Local Purchase Committee have been constituted for this purpose and they have collected quotations & scrutinized. On the basis of detailed comparative statement, the Committee has recommended that digital printing work may be assigned to M/s. Fountainhead Solutions Private Limited, Gurgaon, Haryana, as per the standard norms and conditions.
- 29. An amount of Rs.1,09,147/- (Rupees one lakh nine thousand one hundred forty seven only) has been incurred for digital printing of 150 copies of Annual Report of CARA for the year 2015-2016 under the Rules 146 of General Financial Rules (GFR), 2017. The Steering Committee has approved the expenditure of Rs.1,09,147/- for the above-mentioned purpose, in the 10th Meeting of the Steering Committee of CARA was held on 01/09/2017 (Agenda No. 1 refers). The same is placed for information of Steering Committee.

Decision:

30. Approved. However, it was directed that the present Service Bye Laws of CARA (2002) adopted by the Steering Committee in the first meeting be moved on file for approval of the Ministry as mandated under Section 69 (3) (c) of the JJ Act, 2015.



A Committee consisting of Dr. Jagannath Pati, Joint Director, Ms. Richa Ojha (Administrate Officer-In charge) and Ms. Anju Budhiraja, DEO scrutinise the applications and recommended to appoint M/s Gopal Chopra & Associates, Chartered Accountants, 34, Babar Lane, Bengali Market, New Delhi, as Internal Auditor on a fees of Rs.26,000/- per year excluding taxes as applicable, being the lowest quoted.
- 40. Steering Committee may please approve to appoint M/s Gopal Chopra & Associates, Chartered Accountants, 34, Babar Lane, Bengali Market, New Delhi, for the financial year 2017-18 on an annual audit fee of Rs. 26,000/-(Rs. Twenty six thousand only) plus taxes as applicable from time to time. The contract may be further extended for another two years basis on the performance of the firm and approval of the competent authority.

- 42. Other pending issues concerning CARA which need to be proactively pursued for enabling CARA in discharging its statutory objectives are as under:-
 - (i) Implementation of 7th Pay Commission for employees of CARA;
 - (ii) Revision of Rules and Regulations of CARA and Recruitment Rules of CARA, as it has become a Statutory Body;
 - (iii) Restructuring Proposal;
 - (iv) Requirement of Additional Fund of Rs.79 lakhs for the purpose of investment against leave salary and gratuity provisions;
 - (v) Central Pool Accommodation for CARA employees.

Decision:

- 43. Following updates were discussed:-
 - (i) File is under consideration and will be implemented after approval from the competent authority.
 - (ii) It is under process with the Ministry.
 - (iii) File has been forwarded to MoF and the same would be pursued by the Ministry.
 - (iv) The proposal is already under consideration of the IFD.
 - (v) Steering Committee was of the view that CARA may explore option of purchasing of flats for residential accommodation of CARA employees. There are DDA flats available in areas like Vasant Kunj which could be looked at.
